**To be eligible for the addiction recovery program at Harvest House Atlantic, you must:**

- Be 21 years or older, and suffer from life controlling addictions such as: alcohol or drugs among others.
- Understand that we are not a detox facility; therefore, clients may be required to complete a certified detoxification program prior to entry.
- Complete a drug screening upon entry into the program.
- Complete an interview with the Recovery Program Minister.
- Be committed to receiving long term care.
- Be open to Faith in Christ principles that aid in recovery.



## **Program Resident Agreements:**

Please read the following Harvest House Atlantic Program Agreements and initial each statement to verify that you full understand and agree with it:

1. I understand that the Harvest House Atlantic program is 9 months long.
2. I understand Harvest House Atlantic is a inter-denominational faith-based rehabilitation program in which the primary goal is wholeness through the power of God.
3. I will take full responsibility for my recovery. The more I put in, the more I will get out
4. I agree to participate fully in the other structured components of the program to my best ability
5. I agree to be clean and sober upon arrival.
6. I agree that all situations with Federal and Provincial justice departments must be disclosed so appropriate arrangements can be made.
7. I understand that cooperation is mandatory with staff when dealing with financial, medical, and judicial issues.
8. I understand that I must submit to a search of my belongings upon entering the facility.
9. I understand that I must participate in all group activities and classes.
10. I understand that I must abide by the house agreement as stated in the attached literature.

Please note: Prior to acceptance by Harvest House Atlantic, you will be required to participate in an interview of approximately 60-90 minutes. During this interview, we will require you to be truthful about your life, as well as your addiction problems. We may also ask to speak with significant others and family in your life, to help gain a better understanding of you and your application.
